Information	CB Harbor	"No Wake" Harbor Masters have authority under Section 10 of the Municipal Code to enforce "No Wake" in the Harbor from the AICW at the NC Wildlife boat ramp to the Municipal Marina. "Wake- A wake occurs when a boat goes above slow minimum speeds and/or produces breaking white water by its means of propulsion" (Town Code Section 10-3). Most boats will produce some type of water disturbance by its propulsion at idle speed. Tidal current and wind will also affect the wake produced. Boats must operate at the minimum speed to control the vessel. The Harbor Masters engage with boaters to educate, and enforce Town Code in order to protect property in the Carolina Beach Boat Basin.
